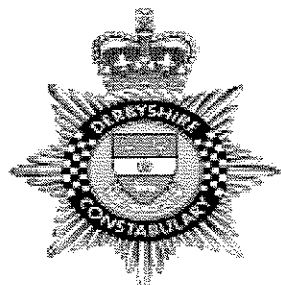
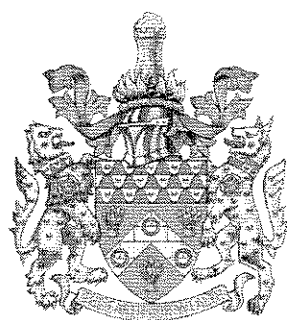

**APOLOGIES**

Apologies for absence from the Meeting were received from District Councillor M. Stanton, J. Burley, N. Cumming, J. Cownie, A. Gifford, Mr. and Mrs. A. Gillespie, J. Orme, K. Overton and J. Stamford.

RA/27. **POLICE ISSUES**

Sergeant T. Cadman addressed the Meeting, giving an update on police issues. He advised that figures for reported crime had recently reduced by 7.5% and there had also been a reduction in assault crimes with injuries by 27%. However, burglaries had increased by 30% across the County.

**It was agreed that Derbyshire County Council would investigate the matter further and report back at the next Meeting.**

RA/28. **CHAIRMAN'S ANNOUNCEMENTS**

The Chairman advised that the District Council had learnt of the sad news of the passing away of Mr. Derrick Adams of Hartshorne Parish Council. Those present at the Meeting stood for a minute's silence in honour of Mr. Adams.

RA/29. **MINUTES**

The Minutes of the Repton Area Forum held on 27th January 2009 were noted.

Arising from Minute No. RA/22, paragraph 3, in connection with the re-erection of road safety signs along the A514, the Forum Liaison Officer advised that the County Council did not intend to provide Traffic Orders, although the Traffic Safety Officer had advised that the traffic calming measures would be made more permanent. Further traffic issues were raised in the areas of Blackfordby Lane, Butt Lane and the Clock Garage roundabout at Woodville. It was requested that the Ward Members be advised of further progress with regard to these issues.

**It was agreed that Derbyshire County Council would investigate the matter further, in consultation with the local Ward Members and report back to the next Meeting.**

With regard to Minute No. RA/23, paragraph 11, in relation to Willington Station, concern was raised regarding the untidy condition of this site.

**It was agreed to forward a letter to Network Rail requesting that the site be tidied.**

RA/30. **PRESENTATIONS FROM THE DERBYSHIRE PRIMARY CARE TRUST**

The Area Forum received presentations from Keith Mann, Head of Dental and Eye Care Commissioning and Roopam Carroll, Practice Based Commissioning Manager from the Derbyshire Primary Care Trust (PCT), to provide information on the services provided by the Trust in the local area.

It was noted that the PCT was a statutory body legally obliged to provide health services. It was provided with a budget from the Department of the Environment of £1.1 billion, within which the primary and community care budget was £378 million (approximately 34%). The PCT had been established in October 2006 and was now the eighth largest Trust in the Country and positioned within the top 20% of the best performing PCT's. Further details were provided with regard to world class commissioning; the PCT's strategy for "improving health and wellbeing in Derbyshire"; the PCT's priorities; its strategic vision; services provided within South Derbyshire and commissioning issues.

RA/33. **DISTRICT COUNCIL ISSUES – UPDATE ON VISION AND PRIORITIES 2009/14**

The Director of Corporate Services gave an update on the Corporate Plan for 2009/14. It was advised that the new Plan had been developed following a large consultation exercise and the Council had a new vision “Making South Derbyshire a Better Place to Live, Work and Visit”. The Corporate Plan had four new themes:-

- Sustainable growth and opportunities
- Safe and Secure
- Lifestyle Choices
- Value for Money

A brief overview was provided on each of the new themes, followed by the values of the District Council, which included:-

- Put customers first
- Set clear targets
- Act decisively
- Need for success
- Actively listen and resolve problems
- Develop our people
- Maintain value for money via continuous improvement
- Treat people fairly

### **REPORT BACK ON ISSUES RAISED AT THE LAST MEETING**

At the last Repton Area Meeting held on 20th April 2009, at Woodville Infants School, High Street, Woodville the following issues were raised. The issues are listed below, together with progress made to date:-

#### **Derbyshire County Council Issues**

1. Following concerns raised at the last Meeting regarding the Local Authority's policy with regard to dealing with minor offences including anti-social behaviour, the County Council has advised that its Community Safety Partnership (CSP) has been involved in Community Payback initiatives (which have included clean up projects of vandalised areas) as part of a pilot. This was run by Derbyshire County Council Community Safety with Environmental Services and the Probation Service.

Those involved in Community Payback initiatives are offenders who have been charged and processed through the courts and the scheme is not appropriate for young offenders who have caused minor offences.

Any matters relating to young offenders are picked up at a district level by South Derbyshire CSP and their Anti-social Behaviour Officer.

2. At the last Meeting, road safety issues were raised with regard to the four-way traffic lights at the Masons Arms Public House, at the A511/Sandcliffe Road, Midway junction. The County Council has advised that the overhanging tree has been cut back and the signals are now unobstructed.

The County Council's Traffic Signals Manager has confirmed that there is excellent forward visibility on approaching the signal heads and therefore, permanent 'warning' signs would not be appropriate. However, temporary signs have been erected advising of the 'New Traffic Signals' ahead on the approaches to the signals.

### **South Derbyshire District Council Issues**

1. With regard to the untidy condition of the Willington Station site, the Council's Senior Enforcement Officer is investigating this matter.
2. During the Derbyshire Primary Care Trust (PCT) presentation at the last Meeting, discussion was undertaken regarding expenditure by the PCT of capital sums accumulated from Section 106 Agreements, following significant residential developments. Any further information received from the PCT in this regard will be reported at the Meeting.
3. It is anticipated that a representative from the Environment Agency will attend the next Meeting, once the date has been finalised, to advise further on the risks of airborne dust causing a potential health hazard. This was requested following concerns raised regarding the business activities of a local company in Woodville.
