Report of the Chair of the Resources Improvement and Scrutiny Committee

WORK PROGRAMME 2008/2009

1. Purpose of the Report

To agree the Committee's work programme for 2008/09.

2. Proposed Work Programme

2.1 The following reviews have been proposed to be undertaken by the Resources Improvement and Scrutiny Committee in 2008/09:

- ❖ Budget and Efficiency Savings
- ❖ Place Shaping
- ❖ Community Cohesion

2.2 **Budget and Efficiency Savings:** The Resources Improvement and Scrutiny Committee did not undertake a comprehensive review of the budget and efficiency savings in 2007/08. The County Council has set an efficiency target of £7.331m for 2008/09.

It is proposed that the Resources Improvement and Scrutiny Committee undertakes a similar exercise to that performed in 2006/07 and identifies progress against the efficiency targets and the impact these may have on service delivery.

2.2 **Place Shaping / Community Cohesion:** The Resources Improvement and Scrutiny Committee received a presentation on the CPA in January 2008. The CPA report identified the issues of place shaping and community cohesion as being areas where the County Council could improve. It is therefore proposed that the Resources Improvement and Scrutiny Committee looks at these

two issues and identifies how the Committee can contribute to the required improvements.

- 2.3 In addition to the above reviews the ongoing review looking at 'maximising community benefits through regeneration' is to be completed.
- 2.4 It is recognised that there needs to be a degree of flexibility with any work planning processes and the Committee should note that it will be possible to vary its work programme through the year should more pressing matters requiring scrutiny arise.

Flexibility may be particularly pertinent in 2008/09 when the Local Government and Public Involvement in Health Act 2007 places greater responsibilities upon Improvement and Scrutiny Committee's regarding:

- ❖ Calls for Action
- ❖ Local Area Agreements

These issues, amongst others, are the subject of the ongoing review of Derbyshire County Council's scrutiny function.
